

**DECLARATION OF LINDA YOUNG
IN SUPPORT OF NOTICE OF
SUBSEQUENT VIOLATIONS**

I, LINDA YOUNG, declare:

1. I have worked for nearly 18 years in the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) and its predecessors-in-interest. I make this declaration from my own personal knowledge. If called as a witness, I could and would competently testify to the contents of this declaration.
2. I am currently working for ATF as an Area Supervisor for the Seattle Field Division and assigned to the Spokane office, the Field Division encompasses the states of Alaska, Hawaii, Idaho, Oregon and Washington as well as the Pacific Trust Territories and Guam. An Area Supervisor supervises investigators who conduct inspections to assess firearms and explosives industry compliance with the Gun Control Act and the Violent Crime Control Act of 1970.
3. On May 23, 2007, ATF commenced an inspection of Red's Trading Post (Red's) at its

licensed business location in Twin Falls, Idaho. The inspection was conducted by myself and investigators Hansen and Williamson and was conducted to determine whether Red's was in compliance with the Court Order dated April 30, 2007. During the course of the inspection three different categories of violations were found of the Gun Control Act and its implementing regulations. A copy of my inspection report including the report of violations I issued to the licensee is attached and included as Exhibit A.


